

OFFICIAL RULES OF PLAY
St. Joseph's Hospital Foundation Lottery

OFFICIAL RULES: By participating, entrants agree to be bound by these Official Rules and by the decisions of St. Joseph's Hospital Foundation which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, provincial and local laws.

NET PROCEEDS: All net proceeds of the Raffle will benefit the St. Joseph's Hospital Foundation, (hereafter known as "Sponsor") and the programs and charitable donations that Sponsor supports.

All prizes must be accepted as awarded, are non-exchangeable and have no cash value other than the Early Bird Cash Draw. For safety and regulatory compliance, the Early Bird Winner will be paid by cheque.

PURCHASING RAFFLE ENTRIES: The following ticket prices and corresponding "ticket numbers" are available for purchase:

1 for \$75, 3 for \$195

Tickets will be available for purchase online at www.sjhf.org/lottery and in-person at St. Joseph's Hospital Foundation located at 1176 Nicholson Road, Estevan. Ticket purchases are powered by Tap50:50.

NUMBER OF RAFFLE TICKETS: There is a maximum 1300 ticket packages available with a maximum of 2100 tickets available to be sold for the entire length of the Raffle:

900 ticket packages at 1 ticket for \$75 for a total of 900 available tickets
400 ticket packages at 3 tickets for \$195 for a total of 1200 available tickets

ELIGIBILITY TO ENTER: In order to be eligible to purchase a ticket and win a prize in this raffle, you must meet the following eligibility requirements:

1. You must be 18 years of age or older;

2. You must be located in the Province of Saskatchewan at the time you purchase the ticket;

INELIGIBLE PARTIES: Employees, officers, directors, shareholders, members, agents and consultants of Tap 50:50 Event Consultants are NOT ELIGIBLE to participate in the Raffle or to win a Prize.

DRAWS FOR WINNERS: The following outlines the methodology for selecting Winners

- The Grand Prize draw, secondary prize draws and winning ticket announcements will take place September 29th, 2018 at 6:00PM at the Power Dodge Ice Centre 701 Souris Ave, Estevan, SK S4A 2T1
- The Early Bird Draw will take place July 31st, 2018 at 3:30pm at St. Joseph's Hospital 1176 Nicholson Rd, Estevan, SK S4A 0H3
- Winning ticket numbers will be selected with Tap50:50's certified computer-hosted random number generator (the "**RNG**").
- The winning ticket numbers will be announced live and the winner will be notified by phone. The winning ticket number can also be found online at www.sjhf.org/lottery
- The contact information provided at time of ticket purchase will be used to contact the Winners
- All winning tickets will be returned to the draw barrel and will be eligible for all draws.

DETERMINATION OF OFFICIAL WINNERS: The Sponsor shall have the sole discretion to determine whether each Potential Winner is an official winner of a Prize (an "Official Winner"). Sponsor's decision concerning the identity of all Official Winners shall be final and binding. To become an Official Winner: a Potential Winner must be eligible to participate in the Raffle under these Official Rules and must not be in violation of these Official Rules as determined in Sponsor's sole judgment.

AWARDING OF PRIZES: The following outlines the methodology for Winners to receive their prize:

- A Prize will be awarded to Potential Winners who has been designated by Sponsor as Official Winners. The Grand Prize and Secondary Prizes must be accepted as awarded with no cash alternatives.
- The Early Bird Prize winner will be paid by cheque
- The Grand Prize Winner will be required to sign a full and final release prior to vehicle title being transferred.
- Winners will have a maximum of 365 days, starting from the time when their Winning Ticket number was drawn, to claim their prize
- If a Winning Ticket Holder has not confirmed their acceptance within 365 days, their tickets will be considered "Null and Void" and the corresponding prize will be donated to a charitable beneficiary approved by SLGA in accordance with Section 13 (d) in SLGA Raffle Terms and Conditions

ADDITIONAL RAFFLE RULES AND TERMS

1. All ticket sales are final and no refunds will be issued.
2. A raffle ticket will be deemed void and prize not awarded if payment is reversed.
3. A raffle ticket will be deemed void and prize not awarded if there is proof that the ticket was stolen, not issued, ineligible, altered, counterfeit, or printed in error.
4. By purchasing a ticket, you are agreeing that if you are a winner of a prize, St. Joseph's Hospital Foundation is permitted to your name and likeness for promotional purposes and your name to be published.
5. The St. Joseph's Hospital Foundation shall not be responsible for lost, late or misdirected mail.
6. If the ticket you purchase includes more than one name, the St. Joseph's Hospital Foundation is permitted to award a prize won by that ticket to only one individual named on the ticket. St. Joseph's Hospital Foundation and the Saskatchewan Liquor and Gaming Authority are not responsible for any disputes that may arise between multiple individuals named on a single ticket.
7. The gaming supplier is Tap 50:50 Event Consultants, a company licensed, safe and secure and approved by SLGA

GENERAL CONDITIONS: The Released Parties (defined below under “RELEASE OF LIABILITY”) are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser’s possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; (3) Entries or payments that are delayed, misdirected, undelivered, not fully captured, or garbled as a result of any failure or problem whatsoever with the availability, functionality, operability or use of any network, server, ISP, website, computer, telephone, cable or satellite modem or connection, hand held mobile device or any other computer equipment or connection, whether or not caused by site users, tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), “Errors”), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Sponsor’s sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Sponsor’s sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a “Compromising Event”), then Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries received before the known occurrence or discovery of such Compromising Event. All Entry purchases shall be final, and no refunds or replacements will be issued by Sponsor. Sponsor has sole and final decision on admissibility of entries and the determination of prize winner.

RELEASE OF LIABILITY: Entrants, by participating in the Raffle, agree that The Sponsor and Tap 50:50, each of their respective parents, affiliates, subsidiaries, partners, and advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, shareholders, members, consultants and agents (collectively, the “Released Parties”) will have no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, cost, expenses or damages of any kind, including damages for death, personal injury, property damage.
