

## ST. JOSEPH'S HOSPITAL LOTTERY FOUNDATION 50/50 Terms and Conditions

**OFFICIAL RULES:** By participating, entrants agree to be bound by these Official Rules and by the decisions of St. Joseph's Hospital Foundation, (hereinafter known as the "Sponsor") which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, provincial and local laws.

**NET PROCEEDS:** All net proceeds of the Raffle will benefit St. Joseph's Hospital Foundation and the programs that

Sponsor supports. **JACKPOT PRIZE:** Winner will receive 50% of net sales. **ELIGIBILITY TO ENTER:** In order to be eligible to purchase a ticket and win a prize in this raffle, you must meet the following eligibility requirements: 1. You must be 18 years of age or older; 2.

You must be located in the Province of Saskatchewan at the time you purchase the ticket; **INELIGIBLE PARTIES:**

Employees, officers, directors, shareholders, members, agents and consultants of Tap 50:50 Event Consultants are NOT ELIGIBLE to participate in the Raffle or to win a Prize. **PURCHASING RAFFLE ENTRIES:** The following

**NUMBER OF RAFFLE TICKETS:** There is a maximum of 2500 ticket packages with a maximum of 18,500 tickets available throughout the length of the raffle.

1000 tickets packages at 1 ticket for \$10.00 totalling a maximum of 1,000 tickets

1000 ticket packages at 5 tickets for \$25.00 totalling a maximum of 5000 tickets

500 ticket packages at 25 tickets for \$50.00 totalling a maximum of 12,500 tickets

**THE GAME:** Each ticket represents one chance to win the Jackpot Prize

**THE DRAW:** Potential winners will be selected using Tap 50:50's certified random number generator. The draw will be made September 29th, 2018 at 6:00PM at the Power Dodge Ice Centre 701 Souris Ave, Estevan, SK S4A 2T1. The winning number will be announced live and winner will be contacted by phone. The winning ticket will be posted online at

[www.sjhf.org/lottery](http://www.sjhf.org/lottery) **DETERMINATION OF OFFICIAL WINNER(S):** Sponsor shall have the sole discretion to determine whether the Potential Winner is an official winner of the Jackpot Prize (an "Official Winner"). The Sponsor's decision concerning the identity of all Official Winners shall be final and binding. To become an Official Winner: (1) a Potential Winner must be eligible to participate in the Raffle under these Official Rules and must not be in violation of these Official Rules as determined in Sponsor's sole judgment; (2) that Potential Winner must contact Sponsor by the deadline specified below.

**AWARD OF THE PRIZE TO OFFICIAL WINNER(S):** The Jackpot Prize will be awarded to the Potential Winner who has been designated by Sponsor as an Official Winner. For safety and regulatory compliance, the winner will be paid by cheque. **UNCLAIMED PRIZE**

**PROCEDURE:** An Official Winner will have 365 days to claim their prize. If the Winning Ticket Holder has not claimed their prize within 365 days, or if the Sponsor has deemed the Winning Ticket Holder was ineligible to participate, the Winning Ticket will be considered "Null and Void" and the prize will be donated to a charitable beneficiary approved by SLGA in accordance with Sec 13 (d) in SLGA Raffle Terms and Conditions **ADDITIONAL RAFFLE RULES AND TERMS** 1. All ticket sales are final and no refunds will be issued. 2. A raffle ticket will be deemed void and prize not awarded if payment is reversed.

3. A raffle ticket will be deemed void and prize not awarded if there is proof that the ticket was stolen, not issued, ineligible, altered, counterfeit, or printed in error.

4. By purchasing a ticket, you are agreeing that if you are a winner of a prize, St. Joseph's Hospital Foundation is permitted to your name and likeness for promotional purposes and your name to be published.

5. The St. Joseph's Hospital Foundation shall not be responsible for lost, late or misdirected mail.
6. If the ticket you purchase includes more than one name, the St. Joseph's Hospital Foundation is permitted to award a prize won by that ticket to only one individual named on the ticket. St. Joseph's Hospital Foundation and the Saskatchewan Liquor and Gaming Authority are not responsible for any disputes that may arise between multiple individuals named on a single ticket.

**GENERAL CONDITIONS:** The Released Parties (defined below under “RELEASE OF LIABILITY”) are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser’s possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; (3) Entries or payments that are delayed, misdirected, undelivered, not fully captured, or garbled as a result of any failure or problem whatsoever with the availability, functionality, operability or use of any network, server, ISP, website, computer, telephone, cable or satellite modem or connection, hand held mobile device or any other computer equipment or connection, whether or not caused by site users, tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), “Errors”), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Sponsor’s sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Sponsor’s sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a “Compromising Event”), then Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries received before the known occurrence or discovery of such Compromising Event. All Entry purchases shall be final, and no refunds or replacements will be issued by Sponsor. Sponsor has sole and final decision on admissibility of entries and the determination of prize winner.

**RELEASE OF LIABILITY:** Entrants, by participating in the Raffle, agree that The Sponsor and Tap 50:50, each of their respective parents, affiliates, subsidiaries, partners, and advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, shareholders, members, consultants and agents (collectively, the “Released Parties”) will have no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, cost, expenses or damages of any kind, including damages for death, personal injury, property damage.
